Deadlines to Remember

Prior to September 1, AQHA should receive your <u>completed</u> January show application(s) and any corrections to your December show(s).

2016 Ford Youth World Dates

Next year's Built Ford Tough AQHYA World Championship Show dates are August 5-13. If you have a show during these dates and wish to look at moving it, please let Lisa Pond know and we'll begin working on the change. These date change requests will be worked free of charge (no \$25 fee!).



Level 2 Reminder

Please take a look at your Level 2 classes and ensure the judge has placed enough places to cover the points for that particular class. We are receiving judge's placing cards with not enough Level 2 exhibitors placed.

In scored classes, placing nine should not be a problem. In placed classes, the Level 2 judge's placing card must cover the points in that Level 2 class, plus one.

Ring Stewards:

- Show Secretary give list of Level 2 exhibitors
- Place at least nine in the Level 2 class
- Judges should not know who is entered in Level 2
- Use ladder sheet provided with the Level 3 /Level 2 cards provided by AQHA

Office:

Keep announcer and ring stewards abreast of exhibitors changing levels

Announcer:

- Be clear that the Level 2/Level 3 classes are held concurrently
- Announce Level 2 placings first, announce number entered in the class. Then announce Level 3 placings, announce total number in the class. When getting to a placing that was a "Level 2 " entry, say, for example, "Fourth place was a Level 2-placing entry."

Restructuring of AQHA Steward Program

Based on a recommendation from the AQHA Animal Welfare Commission, the AQHA steward program is being redesigned and rebuilt from the ground up. <u>Read more</u> about how the program will be dissolved to make way for a new and stronger program.

Clenbuterol

Beginning November 1, 2015, clenbuterol will be considered a forbidden drug per AQHA Rule VIO401.

Earlier this year, positive drug tests for detection of clenbuterol in American Quarter Horse racehorses resulted in significant penalties. As previously announced April 24, that policy was expanded to put an end to the abusive use of clenbuterol in show horses, and in time for the 2015 AQHA World Championship Show.
